Based on the recommendation in the above project to reengineer patient care services (as opposed to making incremental change), a reengineering of patient care services was implemented. This project involved the selection of a pilot unit, an internal project director, a project steering committee (top executives and key stakeholders), and an implementation committee (staff at all levels from the pilot unit, the lab, respiratory therapy, pharmacy, quality outcomes, and a physician). An extensive series of day long meetings of the implementation team were utilized to develop a plan for a total redesign of the way care was delivered in this organization. Changes that resulted included: dividing the unit into four small sub-units with permanent RN-lead around the clock teams; reconstructing unit space around these sub-unit requirements including nursing staff space, call systems, etc.; redesigning the RN, LPN, nursing assistant, respiratory

therapist, lab technician, transporter, pharmacist and pharmacy tech, and dietary aid roles; decentralizing high frequency, low skill tasks to the patient care unit staff; the introduction of point of care technologies with special emphasis on documentation and physician communication; the establishment of daily physician-nurse rounding and communication; establishing of new approaches to enhancing ambulation and other activities of daily living such as recognition for; changing the management role to coaching and counseling; establishment of team and unit staff meetings; etc. The results were compelling--patient satisfaction soared upwards as did physician and staff satisfaction, outcome measures improved greatly including discharged patient/family level of understanding of their illness and treatment, skin integrity, patient falls, medication errors (although fraught with measurement problems), length of stay, numbers of procedures ordered etc. Process variables (number of sticks for lab draws, lab procedures, glucometer procedures etc.) stayed at the same level or improved.

Development of a Strategic Plan, Maimanoides Medical Center, Brooklyn, New York, 1996.

The major task of this project was the development of a strategic planning plan. A Strategic Planning Steering Committee made up of the top executive staff and representatives from the physician leadership was facilitated through the steps of values clarification, internal and external environmental scan (largely based on the above project findings), vision development, goal identification, strategy creation, and action planning.

Organization and Market Analysis, Maimanoides Medical Center, Brooklyn, New York, 1995-1996.

Quantitative and qualitative data were analyzed and synthesized into an extensive report of findings which were benchmarked with similar organizations in their own and other markets. Recommendations for the organization focused on first and second level changes that needed immediate attention as well as overall strategic directions for the medical center within the context of its environment.

Assessment of Patient Care Services, McLaren Medical Center, Flint, Michigan, 1995.

An assessment of this 450 bed teaching hospital was conducted. Activities included report and record review, interviews with top executives, managers, directors and department heads, conduct of approximately 60 focus groups with former patients and their families, physicians, and staff from all areas of the organization.
