Be Inspired by the 4th J&J Nursing Hackathon on Building a Sustainable Workforce of the Future



J&J conducts a NurseHack4Health twice a year now in the Fall and Spring. Their most recent Hackathon was focused on Building a Sustainable Workforce of the Future in response to the immediate need to recruit and retain nurses to the healthcare workforce, especially in the face of the ongoing COVID pandemic.

The weekend long hackathon resulted in the formation of 16 teams, with four Track Stars singled out at the end of the competition. Ideas generated ranged from workforce model apps to ways to improve onboarding of new nurses to addressing nurse burnout, among others.

J&J Allergy Prevention QuickFire Challenge



J&J Innovation has initiated a QuickFire Challenge to address the growing public concern over food allergies. Innovators are invited to submit new and unique ways, technologies, or products that possess the potential to prevent food allergies from developing in children when they are young.

Submissions should aim to address one or more of the following focus areas:

- **Risk detection** including connected devices for both point-of-care and at-home prognostics/diagnostics.
- **Interventions & treatments** including preventive therapeutics and health technologies
- **Community platforms** with the potential to establish connectivity, monitor data, educate the public with a specific focus on socio-economic disparities, and assist communities

The award is grant funding from a total pool of \$150,000, in increments of \$75,000, \$50,000, or \$25,000

J&J QuickFire Challenge on Healthcare Transformation Through Nurse-Led Tech Applications

This Challenge is being conducted in collaboration with the American Nursing Informatics Association and the American Organization for Nursing Leadership to come up with ideas and innovations in health technology which leverage this technology to help nurses to lead transformational change which increases efficiency and improves patient outcomes. The Challenge cites that “Robotics, AI, remote monitoring or communication, 3-D printing, portable diagnostics and virtual reality are some examples of how technology can—and will—augment the nursing workforce—and ultimately strengthen healthcare delivery and patient outcomes.”



This Challenge will award the nurse innovator with the most innovative idea(s) up to \$100,000 in grant funding as well as mentoring and coaching from experts across the J&J family of companies.

The Challenge is open to nurses and nursing students.

This prize is open to those 50 and older who are founders or co-founders of an organization who have already proved themselves to be entrepreneurs. This award is a national award in the US that “celebrates people 50 and older who are using their life experience to make a difference. Through the Purpose Prize award, AARP celebrates that creativity,

innovation, and inspiration that life experience brings.”

There will be five winners, each whose non-profit organization will receive \$50,000.

[MTRAC Mid-Stage Funding](#)

MTRAC Awards are part of a statewide program that funds the transfer of technologies from Michigan's higher education institutions to the private sector for commercialization. The awards provide translational research funding and resources for proof-of-concept and late-stage translational studies that exhibit a high potential for success commercially.

The awards are co-managed by U-M's Innovation Partnerships (formerly Tech Transfer) and Fast Forward Medical Innovation (FFMI) and fund up to \$250K, but all awards require a cost share from the researcher/institution. The award comes with regulatory guidance, business plan development, and mentorship from industry and investment experts.

- Tuesday, January 11, 2022 from 4:00-5:30 EST

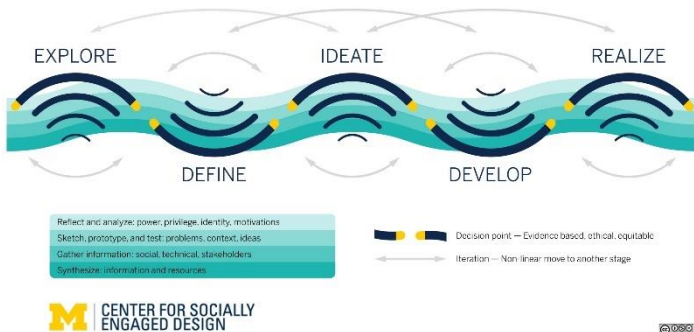
